

# »Hotel FRAVI« in Kürze

# **Brief Description**

The beautiful bathing, spa and holiday hotel Fravi was built as early as 1828. It is located at the northern entrance to the Graubünden village of Andeer. You now have the rare opportunity to acquire one of the most historic 3-star superior hotels in Switzerland. »Hotel Fravi« has been owned by the founding family since its opening over 180 years ago and is now being sold in the course of succession planning.

The unique hotel features 49 inviting comfort double and single rooms, as well as junior suites, with a total of 81 beds, beautiful lounges, a dining room in art nouveau style, a restaurant à-la-carte, a fantastic garden, beautiful outdoor spaces, its own mineral spring and a direct connection to the famous mineral baths in Andeer. On the property where the mineral bath is located, an independent building permit was established until 2056 in favour of the »Schamser Heilbad Andeer AG«, which was also granted the right to use the water of the mineral spring until the year 2056. All properties are owned by Hotel Fravi AG, a company of the Fravi family.
